Minutes: The minutes from the April 2024 annual meeting were accepted on motion by Plantation and Stonecrest

Treasurer Report: The report was accepted on motions made by Royal Highlands and SummerGlen. The dues of \$25.00 for this fiscal year have been and are being collected by the treasurer.

Umpire Clinic Review:

Bob Andrews recapped the clinic held at Continental, with a good turnout. The next two clinics are Plantation 10-17, and Sunlake 1-6-25. All the managers, division reps, and park reps are urged to attend a clinic.

Webmaster Report:

Schedules are being worked on and should be out within a week. Discussion on the number of games being scheduled in Division 1, which will be looked into by Maryann.

Old Business:

- The league will be returning to the Trump Stote 44/375, optic yellow, red, or black stitching at the start of this playing season.

New Business:

- President Falzone presented Continental with a recognition plaque for providing a service to the league over many years.
- The following communities received approval to have sister communities this season: Sunlake, Lakes @ Leesburg, Royal Highlands, SummerGlen, and Legacy.

- The required Draft Verification Document was collected by most of the communities, with the remaining communities to have them to the secretary by the October 18th meeting.
- League dues were collected for the upcoming season.
- Discussion by Bob Andrews on the prospect of performing bat compression tests on bats, but no conclusion has been identified at this time.
- The opcomm is looking into the use of a lower compression ball, that will be used across all divisions during the All-Star game at Spruce Creek, with the league purchasing the balls being tested.
- Two motions were presented and passed by roll call vote: First, the reinstatement of the catchup rule, and second changes to documents reviewed by the opcomm during, the summer meetings, reviewed by the Board, and voted on are locked for that playing season, except a rule that may create a safety concern.
- Both of these revisions have been incorporated into the appropriate league documents.
